

MILLENNIUM CHALLENGE ACCOUNT (MCA)- MALAWI II GOVERNMENT OF MALAWI

GENERAL PROCUREMENT NOTICE (GPN) NO. 7

The United States of America and the Government of the Republic of Malawi (the "Government") signed on September 28, 2022, a Compact for an amount of US\$350 Million, for a program to advance economic growth and reduce poverty in Malawi. The Government is implementing the compact through the Millennium Challenge Account-Malawi II (MCA-Malawi II).

MCA-Malawi II intends to apply part of the funds to payments for contracts for Goods, Works and Services.

MCA-Malawi II has contracted Charles Kendall and Partners to perform Procurement Agent Services on behalf of the Government, for the procurements to be funded by the Compact.

The procurement program for the period 6^{th} January 2025 to 6^{th} April 2025 will include the following:
